Former Acting Assistant Secretary for Indian Affairs Larry Roberts Joins Firm

Mr. Roberts is joining as Counsel in the firm's nationally recognized **Native American Affairs Team**. Most recently, Mr. Roberts served in several high-level positions in the Obama Administration. Since the previous Assistant Secretary's departure at the end of 2015, he led Indian Affairs at the Department of the Interior, serving as the Acting Assistant Secretary for Indian Affairs and the Principal Deputy Assistant Secretary. In these roles, he oversaw approximately 8,000 employees with the Bureau of Indian Affairs, the Bureau of Indian Education, the Office of Indian Gaming, the Office of Indian Energy and Economic Development and all offices that report to the Office of the Assistant Secretary. Prior to serving as the Acting Assistant Secretary, Mr. Roberts served in other Indian Affairs senior leadership positions since 2012, including the Principal Deputy Assistant Secretary and the Deputy Assistant Secretary for Policy and Economic Development.

Prior to his appointment to Interior, Mr. Roberts served as the General Counsel of the National Indian Gaming Commission. In serving as the chief legal officer, he advised the Chairwoman and Commissioners on all matters before the Commission, including: litigation, enforcement actions, Commission decisions, and the adoption of Commission rules and policies.

In addition to his six years of service during the Obama Administration, he previously served as an attorney at the EPA and began his legal career as a Trial Attorney in the Indian Resources Section of the United States Department of Justice, Environment and Natural Resources Division. As a Trial Attorney, Mr. Roberts was responsible for a diverse caseload, including:



treaty reserved rights to hunt and fish, the restoration of tribal lands, defense of tribal water quality standards pursuant to the Clean Water Act, and tribal water rights.

Mr. Roberts earned his J.D. from the University of Wisconsin Law School. He received his B.A. in Political Science and Sociology from the University of Wisconsin - Madison. Mr. Roberts is a citizen of the Oneida Nation.
