Prior to joining the firm, Cameron served as a law clerk to the Honorable Tilman E. ("Tripp") Self, III in the U.S. District Court for the Middle District of Georgia where he drafted detailed orders and memorandum opinions primarily for cases involving Section 1983, health and life insurance disputes, administrative law, medical malpractice, expert opinions, and other civil and criminal matters, including applications of Georgia law. Previously, Cameron served as a law clerk to the Honorable Charles J. ("Charlie") Bethel in the Supreme Court of Georgia.
