HOW LONG HAS THE FIRM HAD A PRESENCE IN CHICAGO?

The Chicago office was launched on March 1, 2023, but it is building on the strong Midwestern presence and stellar reputation of predecessor firm Lewis & Gellen. Founded in 1994 by four attorneys from big firms, Lewis & Gellen grew to over 75 attorneys across the United States and in the UK.

While we have clients from a wide variety of industries, many of our clients are in the food industry. That's pretty logical because we are based in Chicago, known for its stockyard district.

In addition to privately held company clients we also serve as counsel for several publicly traded companies – including many of the major national banks. Our work for the banks includes loan documentation and a lot of commercial workout work, which is collection work. We don't do any consumer-based collection work.
