Kilpatrick Townsend Attorneys Named 2018 North Carolina Super Lawyers

The multi-step process involved soliciting nominations from attorneys across the state (lawyers were not allowed to vote for themselves), followed by a thorough case-by-case review of each nominee. North Carolina *Rising Stars* recognizes outstanding attorneys who are 40 or under, or who have been practicing for 10 years or less. No more than 2.5% of North Carolina lawyers are named to this list.
