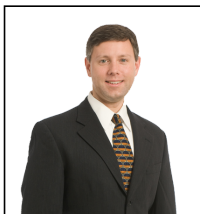
Until earlier this month, Dr. Bernard served as Co-Leader of Kilpatrick Townsend's nationally recognized Electronics and Software Practice Group.
