Kilpatrick Townsend Once Again Achieves Recognition for 2018 Georgia Super Lawyers

Firm Leads in Eleven Categories

Kilpatrick Townsend led all firms with the most *Super Lawyers* listed as **Top 50 Women Georgia Super Lawyers**. The firm also had the most *Super Lawyers* and the most *Rising Stars* listed in **Intellectual Property** and **Intellectual Property Litigation**.

Kilpatrick Townsend has the only *Rising Star* for the entire state for **Criminal Defense: White Collar (Adria Perez)**, for **Native American Law (Mark Reeves)**, and for **Technology Transactions (Josh Ganz)**. Georgia Super Lawyers and *Georgia Rising Stars* are selected through a nomination process, peer evaluation and internal research conducted by Law & Politics. The result is a comprehensive and diverse listing of the top five percent (2.5% for Rising Stars) of Georgia attorneys.

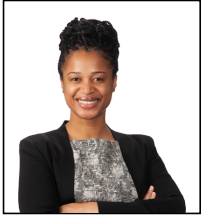
