# Kilpatrick Townsend Attorneys Recognized in 2021 IAM Patent 1000

*Firm Receives Recognition in China & International, as well as U.S. National and U.S. Regional Rankings*

**ATLANTA (July 28)** – Kilpatrick Townsend & Stockton announced today that 25 Kilpatrick Townsend attorneys were named to the *2021 IAM Patent 1000 - The World's Leading Patent Practitioners (IAM Patent 1000)*. The firm earned outstanding distinction in China: Foreign & International rankings, and also achieved recognition in the United States National category, and in five states including: California, Colorado, Georgia, North Carolina, and Washington.

In the **China: Foreign** region, Kilpatrick Townsend was one of only 19 firms ranked. In the **International** band, the firm was one of the leading 34 firms noted with distinction. Kilpatrick Townsend was also one of only 16 firms recognized in **U.S. National, Prosecution** category.
