Kilpatrick Continues to Earn Impressive Rankings in Annual IAM Patent 1000

The Firm Achieved a Record Number of Ranked Individuals

ATLANTA (July 2) – Kilpatrick announced today that a firm record number of **29** Kilpatrick attorneys were named to the [2024 IAM Patent 1000 - The World's Leading Patent Practitioners \(IAM Patent 1000\)](#). The firm earned exceptional recognition in China: Foreign & International rankings, the United States National category, and in six states including: California, Colorado, Georgia, North Carolina, Washington, and Texas.

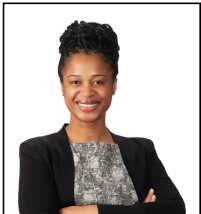
