For Second Year in Row, **Managing IP** Names Kilpatrick Townsend U.S. Trademark Prosecution Firm of the Year

Firm Wins 5 Awards at 18th Annual Ceremony in New York

ATLANTA (May 1) - Kilpatrick Townsend & Stockton announced today that *Managing Intellectual Property* (*Managing IP*) named the firm “**U.S. Trademark Prosecution Firm of the Year**” at the 18th annual “**Managing IP Americas Awards**”, held in New York on April 27th. Now in its 18th year, the program covers several IP practice areas and more than 50 jurisdictions.

Each year, research analysts obtain information from thousands of firms, IP practitioners, and their clients through interviews, email, and online surveys. Firms and in-house teams complete their respective research forms. The research for the IP STARS rankings and the Managing IP Awards program is rigorous and impartial. There is no fee to pay to participate in the research. The awards are not influenced by any commercial relationship with Managing IP, and no firm or individual can pay to influence the results.

Managing IP launched its awards program in 2006. The ceremony attracts hundreds of guests and is regarded as the premier IP law firm awards event in the legal industry.
