Kilpatrick Townsend Attorneys Named 2016 North Carolina Super Lawyers

Adam Charnes Selected to Top 100

NORTH CAROLINA (January 15) -- Kilpatrick Townsend & Stockton announced today that **38** of the firm's attorneys were selected as **North Carolina Super Lawyers** and **North Carolina Rising Stars**.
